Exterior Paint Guidelines May 2016

Seastrand's new exterior paint palette is based on Kelly Moore brand paint colors and Behr Premium Exterior Wood Stains. The palette remains the same with the previous Behr paint colors being converted to Kelly Moore colors, with the addition of three new window trim and fascia options. Kelly Moore assisted in creating the palette and is offering Seastrand residents a discount at the Kelly-Moore store located at 649 Pacific Avenue in Alameda. In order to take advantage of the discount please mention you are a Harbor Bay homeowner and use account number 922-PE6893.

When considering painting your home, please visit the Community Office so that you can view the paint palette, which may be checked out with a \$50 deposit (check or credit card).

Although the Seastrand Board strongly recommends using Kelly Moore paints, owners may ultimately use any paint brand they wish as long as the paint brand selected for repainting has the same quality and color characteristics. An Architectural Application is required for house painting; please indicate the approved color names on the form.

Non-standard color schemes combinations may be proposed by homeowners and will be considered on a case-by-case basis by the Seastrand Board of Directors. If you are proposing to paint a color outside of the approved scheme, you will be required to include two color samples for each color you are proposing, stating the paint brand, code, and where on the home it will be used. At the option of the Seastrand Board of Directors a new color scheme may be added to the approved paint palette.

Fences and gates shall not be painted. Other yard structures shall not be painted unless specifically approved by the Seastrand Board of Directors.

Paint Gloss Categories:

Exterior paints are comprised of five gloss categories. The following exterior paint finishes are permitted under each category:

If you hire a contractor to paint your home, please provide the contractor with a copy of the Architectural Application approval letter and these house painting guidelines.

No changes should be made to the color scheme after it has been approved unless the proposed changes are resubmitted to the Community and Seastrand Architectural Committees and are approved.


